The Department for Children Schools and Families (DCSF) and the Department of Health (DH) have published a joint strategy, **Healthy lives, brighter futures - The strategy for children and young people's health**, which presents the Government's vision for children and young people's health and well-being. It includes plans for more health visitors, a strengthened role for Sure Start Children's Centres and £340 million to support children with disabilities and their families.

### **Early learning and childcare**

The Department for Children, Schools and Families (DCSF) has published the Next Steps for Early Learning and Childcare: Building on the 10-Year Strategy, which outlines plans to drive forward the 2004 Childcare Strategy. The paper considers making it a legal requirement for childcare professionals to have an A-Level equivalent standard, enabling parents to stretch the free childcare offer to cover holidays, developing a price comparison website of childcare and expecting Local Authorities to give more childcare and activities options for 5-14 year olds.

### **New assessment system for local government**

The new Comprehensive Area Assessment (CAA) builds on the former system of star ratings for councils, or Comprehensive Performance Assessment (CPA). In recognition of the diverse needs of different areas, under the new system

there will be no league table-style rating system or formulaic calculation of scores for the area.

### **Play**

Local authorities are bypassing the voluntary sector in the delivery of new play services, play providers have claimed. A number of play associations have found that councils have not consulted with them sufficiently on how to use millions of pounds of cash allocated by The Children's Plan for new play areas. #### **...and small children's charities**

Four out of ten small children's charities are in a vulnerable funding position and may have to close, according to a new report published by Children England, the national umbrella organisation for the children, young people and families voluntary sector.

Children's England's report Small Change?, which draws on a survey of 125 small children's charities with an annual income of under £250,000, finds that children, young people and their families may lose out on vital services due to a lack of funding and support. The report also raises concern that despite improvements to the way that children's services are planned and developed, many smaller charities are continuing to find it difficult to get their voices heard or to have influence.

### **Community Action Hampshire (CAH)**

### **National survey of third sector organisations**

Commissioned by The Office of the Third Sector and conducted by Ipsos MORI, this survey involved almost 50,000 charity, social enterprise and voluntary organisations. Initial findings show that 51 per cent of respondents said they felt public sector bodies had no overall influence on their success. Further findings from the survey are due to be published in April.

### **Supporting the voluntary sector**

The Local Government Association and NCVO have jointly published Backing Communities: local solutions, to highlight some of the positive ways in which local authorities can work with voluntary and community organisations in response to the recession. The report explores the likely impact of the recession on the sector and the potential implications of this for local authorities. It also suggests actions that both local authorities and voluntary and community groups can take to mitigate the negative effects of the recession on the communities they serve.

### **Child neglect**

Action for Children has published a survey which finds one in four adults have been worried that a child they know or living in their area is being neglected, and over a third did not tell anyone about their concerns. The survey was commissioned to highlight the difficulty of identifying and preventing the neglect of children.

### **CAT mark**

CAT stands for the Care Action Team. It was Hampshire's Care Action Team who recognised the need for young people to have their say and be involved in assessing young people's services.

The CAT mark is a stamp of approval for young people's services. It is awarded by young people who have been trained as CAT-mark assessors. They assess services, organisations and projects against set conditions.

### **Disabled parents**

The Commission for Social Care Inspection (CSCI) has published a study which shows that few councils are achieving the right balance between supporting disabled parents and supporting children who help look after their disabled parents. The report calls for councils to be clear about the roles and responsibilities of adults and children's services to ensure that disabled parents and their children receive coordinated support that recognises the needs of the whole family.

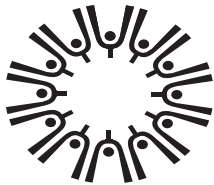
